- Foundation for the Support of Education at the Aviation Valley Association

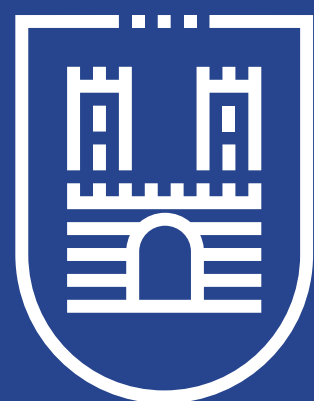
