- d. the recipients of personal data contained in this recommendation form will be entities providing service of administrators' IT systems and software, external entities providing services to administrators, and entities authorized to obtain personal data on the basis of law regulations (including public administration bodies),
- e. the data subject has the right to request the administrators to provide access to personal data, to correct them, delete or limit their processing, in cases specified in the provisions of the GDPR,
